## MIAA Member Station Rights Fees

### **Radio Stations (including online webcasts)**

Stations may become MIAA Member Stations by:

- Paying annual dues of \$50 per school (ex: Station covers 9 schools x \$50 = \$450)
- Minimum annual payment is \$250
- The Station agrees to air \$750 per school worth of run-of-station MIAA Public Service Announcements throughout the year and an additional \$100 worth of Public Service Announcements during MIAA tournament events. Rates shall be based on the lowest published rate as it appears on the station's most recent rate card.  
**The Station agrees to submit verification of compliance.**
- If a Member Station wishes to cover a tournament game of a school not listed in this contract the non-member rates, listed in the current MIAA Media Guide, will apply. An Individual Event contract will be required.
