### **Fall Season Reminders:**

#### Fall 2023 Schedule Commitment Deadline

With practices and tryouts for Fall 2023 sports now under way, and competitions scheduled to begin in a little more than a week, this is a reminder that the MIAA schedule commitment deadline is **Friday, September 1**.

#### All schedules for **Cross Country**, **Field Hockey**, **Football**, **Fall Golf**, **Soccer**, **Fall Swim & Dive**, and **Girls Volleyball** must be entered into Arbiter by the end of the

day on September 1. After that point, no changes can be made to your opponents or the number of games/matches that can be played.

Please be sure to check the <u>MIAA Sport Limitations</u> <u>Information Sheet</u> for the maximum number of competitions allowed per week and per season in each sport.

After the September 1 commitment deadline, all schedules will be considered **FINAL**.

#### **Cooperative Team and Middle Level Waiver Applications**

Last year the DAC's placed deadlines for submitting Cooperative Applications and Middle Level Waiver Applications. ML waivers and Coop Applications "... cannot be applied for after the first possible date of competition for each season." The final day(s) of application for Fall sports are:

•	Golf:	August 25
•	Football:	September 5
•	All other sports:	September 3

Applications submitted after these dates will not be

considered. Link(s) to <u>Middle Level Waiver</u> and <u>Cooperative Team</u> guidelines.

#### **MIAA Tournament Passes**

MIAA Tournament Passes will be mailed to the High School Principal beginning the week of August 28<sup>th</sup>, to those schools who have submitted their Institutional Dues.

#### MIAA 2023-2035 Handbook – Revision, Clarity, Searchability

The current 2023-25 MIAA Handbook has a new look for greater clarity and organization. All new rules, voted in January 2023 have been incorporated into the current version of the handbook found on the MIAA webpage. Additionally, during this summer, the entire handbook was reviewed and rewritten for clarity to increase better understanding for member school leaders. Part of this process involved removing all icons from the book. Many icons contained important information which is now incorporated into the appropriate rule. Icons were not searchable for content but with all necessary language removed from the icon and inserted into the rule it will be easier to understand and find necessary information.

At the beginning of the book, the previous long and detailed passages have been converted to links that can be accessed when necessary. This reduces the length of the book overall but includes links to all of the same information. A few other big changes include combining all Bona Fide Team Member Information into one rule, Rule 45. Previously there were three rules, 45, 88 and 96 with Bona Fide information. All information is the same, albeit rewritten for clarity and for the avoidance of repetition. Another rule of note is Rule 49: Sportsmanship. This rule was rewritten to help AD's and principals find information easily and quickly for each constituents' responsibilities: officials, student, coach, and athletic director.

#### **New Student and Coach Disqualification Forms**

The <u>MIAA Student Contest Disqualification Form</u> and <u>MIAA</u> <u>Coach Contest Disqualification Form</u> have been updated for the 2023-24 school year. Please make sure to have these updated forms available at all interscholastic contests and discard any previous versions of the forms. When a student or coach is disqualified from a contest, these updated forms must be completed by the game official and submitted to the athletic director in charge of the contest, or designee, before leaving the site. Please reference <u>MIAA Handbook</u> <u>Rule 49</u> for additional school requirements when a student or coach is disqualified from a contest.

#### **MIAA Welcomes New Chief Technology Officer**

## **MIAA Student Eligibility and the Waiver Process**

Please be reminded of the 2023-25 MIAA rule changes that were approved by the membership and effective July 1, 2023 (<u>click here</u>). While each rule change should be reviewed carefully, we wanted to bring your attention to the following rule changes that directly impact student eligibility and the waiver process:

- League advisory votes are no longer required to be submitted with student eligibility waivers (proposal 39).
- Additional language was approved to be added to MIAA rule 59, Time Allowed for Participation After First Entering Grade Nine (proposal 19). This will impact waivers beginning with the 2023-24 school year. In these instances, waiver applications cannot be submitted and will not be accepted for review. This rule change was supported by a vote of 311-24-10.
  - Added to rule 59.1.1 A waiver shall not be permitted for a student who has demonstrated proof of passing grades and earned enough credits to advance to the next academic grade level.
  - Added to rule 59.2 A waiver will not be permitted for students who choose to repeat a grade they have already successfully passed. These instances do not satisfy the criteria outlined in rule 59.2.
- Beginning in 2023-24, all standard coach and student contest disqualifications in all sports will be one (1) game, unless indicated otherwise by the game official on the disqualification form *(proposal 12 and 13)*. However, any disqualifications earned during the 2022-23 school year that have not been served, will remain two (2) games, if that is the length of the suspension owed.
  - For example, if a soccer, ice hockey or baseball player was ejected from the final game of the season during this past school year, they would still owe two games to start their respective season next school year. The rule is applied in this manner because the suspension was earned prior to the rule change going into effect when a standard disqualification for these sports was an automatic two games.

As a reminder, below are the seasonal deadlines for student eligibility waiver submissions as outlined in MIAA rule 87.1. These are firm deadlines and late waivers will not be accepted.

- Fall September 22, 2023
- Winter December 15, 2023
- Spring April 1, 2024

#### **MIAA Constitution Revision**

At the 2023 MIAA Annual Meeting, the Assembly approved revisions to the <u>MIAA Constitution</u>.

#### **MIAA Launches Website Rebuild Initiative**

The MIAA recently partnered with Gravity Works Design, based in Lansing, Mich., on an initiative to redesign and rebuild the association's website, <u>miaa.net</u>. The project launch follows a nearly yearlong process of discovery and vetting of potential partners, which included input from the Ad Hoc Technology committee and the MIAA Board of Directors.

Among the top priorities of the redesigned website will be:

- Ease of use for school personnel, student-athletes, officials, and the general public
- An improved infrastructure for submitting forms and other critical data
- A more modern approach to communicating important and timely MIAA information and news of general interest
- Integration with Arbiter to present schedules, scores, and tournament information

The initial phase of the new website is projected to launch in early 2024, with additional features to be unveiled in later phases.

#### **Sports Medicine Resources**

As the school year is beginning, please be prepared for practice and competition with medical and safety resources.

Medical Personnel at varsity football games: Please remember that for all varsity football games, each team must employ a licensed physician, licensed athletic trainer or certified EMT to be with their team.

Heat Stroke and other resources: This Monday, first day of fall sports practice/tryouts for many sports, a school had a WBGT reading of 81 for the practice. (see MIAA Heat Modification Policy) This allows for a maximum of two hours' practice, the next level begins at 84.1, limiting practice to 1 hour. The final level begins at 86.1 not permitting practice at all. During that practice, a student sat down to hydrate and rest, appeared fine at first but very quickly turned non-responsive. All staff and students quickly responded with an ice bath and called 911. The result was positive in the end due in large part to the preparation, equipment/resources on site, and action by coaches, students, and medical staff. Just a reminder for all to prepare for emergency with careful planning.
