## An Update from Executive Director Robert Baldwin

#### **Supreme Judicial Court Decision**

On Monday August 29, 2022, the Supreme Judicial Court ("SJC") upheld the MIAA's decision denying a waiver to a student-athlete for a fifth year of play, and vacated a Superior Court order that had allowed the student-athlete to play. The SJC held that courts reviewing MIAA student eligibility decisions must use the "arbitrary and capricious" standard of review, which allows courts to overrule MIAA decisions only when they lack any rational basis. Concluding that MIAA's <a href="Eligibility Appeal Board">Eligibility Appeal Board</a> (EAB) fully considered all the evidence presented in light of all the factors necessary for a waiver, the SJC ruled that the Board's decision was plainly not arbitrary and capricious and should have been upheld.

#### **Board of Directors Actions**

#### **Required MIAA Form Acknowledging MIAA**

Rules 57 & 59 - On August 17<sup>th</sup>, the MIAA Board of Directors adopted a new form that will be required for any students transferring to or reclassifying at an MIAA Member School. This required form is intended to serve as a supportive document for MIAA Member School leaders, the student-athletes and their families to ensure they are educated on MIAA rules and the future impact they may have on one's eligibility. This form must be implemented in schools beginning on October 1st. The form will be added as page two of the MIAA Form 200, as well as a standalone Form #9, titled "Acknowledgement of MIAA rules 57 and 59.

#### **District Athletic Committees (DAC)**

The Board of Directors delegates to the District Athletic Committees (DAC) the supervision of athletics and the adjudication of protests, disputes, conflicts or controversies within their districts. They also serve as the Nominating Committee of the Association, and directly appoint a principal and athletic director to each MIAA Sport Committee. They control the alignment or realignment of Leagues, approve all cooperative (click icons) and middle school on high school team's requests within their districts, and play an important role in the Rules Change Process, given that they have the opportunity to review all input on each rule before recommending a position to the Board of Directors. District Committees will also have the responsibility of approving requests within their districts of cooperative teams looking to add Middle School participation in one or more of their co-operative teams. The Board of Directors or Executive Director may request them to "fact find" or to conduct hearings with regard to alleged rule violations. That authority also permits District Athletic Committees to determine and enforce appropriate penalties.

# Measures to Eradicate Hate and Bias Through the Platform of Sports

The MIAA will continue to take a visible role in helping our member schools address incidents of bullying and inequity among athletes and fans. A collaboration with the Attorney General's Office, the Department of Elementary and Secondary Education, the Massachusetts Association of School Superintendents, the Northeastern University Center for the Study of Sport in Society, the Anti-Defamation League and other key stakeholders throughout the Commonwealth unveiled a forum on addressing hate and bias in schools on April 5, 2022. Next steps will be a statewide convening targeting the week of Sept 26 or Oct 3 to begin proactive measures to eradicate hate and bias through the platform of sports.

# NFHS Launches Free National Book Study Supporting DEI Initiatives

A four-week national book study discussing diversity, equity and inclusion will be conducted via a virtual webinar series by the NFHS from October 19 to November 9. The study will feature the book entitled "From Athletics to Engineering: 8 Ways to Support Diversity, Equity and Inclusion for All," coauthored by Johnnie Johnson and Dr. Michael E. Webber. #### Name, Image, and Likeness (NIL) Update

Some athletic directors have started to receive inquiries and/or contracts for MIAA student athletes. As initial advice, it is important that the student and family carefully read MIAA Rule 47, Amateurism -- (Name, Image, Likeness (NIL) - Definitions - Loss of Amateur Standing) to thoroughly understand all permitted activities. The MIAA staff, in collaboration with MSSADA, is working to develop resources and support for school leaders to help navigate and better understand the current landscape of NIL.

# **Student-Athlete of the Month Award**

Nominations are now being accepted for the MIAA Student-Athlete of the Month Award. This award recognizes two student-athletes on a monthly basis (from September through April) who display excellence in the areas of academics, athletics and community service. Students in grades 9-12 who attend MIAA member schools are eligible to receive the award. Nominations must be received by the last day of each month in order to qualify for that month's award.
