Fall 2024 Power Rankings

Tournament Entry - Opt-in vs Opt-out

Beginning with the Fall 2024 season schools will not be required to submit a tournament entry. Schools will be required to submit communication if choosing to opt out of tournament play. This new process is only for sports that utilize the MIAA power ranking system. Hybrid sports will continue to require a tournament entry process.

Un-Played Contests: Forfeit and No-Contest Determinations

In the event a contest is unable to be played on the scheduled date, for any reason, every attempt should be made to reschedule the contest on the next available date for both schools. If the competing schools are unable to find a makeup date, both schools must use this **FORM** to request a determination of a "Forfeit" or "No Contest" for an un-played contest. All sections must be completed thoroughly.

This information will be reviewed by the Fall Seeding Committee consisting of the chair or designee from each fall sport and TMC representatives. Tournament Directors and Executive Liaisons may be present but are non-voting members. All decisions made by the Seasonal Seeding Committee are final. Once a determination is made, it will be shared with the schools.

Schools do not need to use the Forfeit/No-Contest form in the following circumstances: Canceled season (Rule 18); Overscheduling (Rule 34.6); Ineligible player (Rule 86).

Please **DO NOT** enter a score into Arbiter for any contest in question until a determination has been made by the Seasonal Seeding Committee. Any unverified score can affect the power rankings in that sport.

Swimming Software - Hy-Tek Team Manager

Field Hockey Protective Equipment Reminder

The MIAA follows NFHS Rules for Field Hockey. We would like to remind you of the following rule regarding player equipment:

NFHS Rule 1, Section 6, Article 5 states: "Goggles may be worn by all field players. A face mask may be worn by field

players throughout the game. The face mask shall be smooth, rounded, preferably transparent or single-colored and fit flush with the face. It shall not be attached to any hard, unyielding headgear (even if padded)."

Additional Important Points:

- Goggles are optional for field players, not mandatory.
- Face masks are permitted for all players during the entire game.
- Face masks must be smooth, follow the contours of the face, and be a single color or transparent.
- Steel or cage-type face masks are not allowed.
- Players wearing face masks must not conduct themselves in a manner that increases risk to other players.

Please ensure that all coaches, players, and officials are aware of these equipment guidelines. If you have any questions or concerns, don't hesitate to contact the MIAA office.

2024-25 Schedule Commitment Deadline & Process

Three days before the Schedule Commitment deadline, MIAA staff will produce and publish schedules for each sport based on the available data for review and verification by member schools. Below is the breakdown for the rest of the 2024-25 school year:

- WINTER 2024-2025
 - o First contest date: Thursday, December 12
 - Schedule data published for review: Tuesday, December 17
 - Schedule Commitment deadline: Friday, December 20

- SPRING 2025
 - o First contest date: Thursday, March 27
 - Schedule data published for review: Tuesday, April 1
 - o Schedule Commitment deadline: Friday, April 4

Please be sure to check the <u>MIAA Sport Limitations</u> <u>Information Sheet</u> for the maximum number of competitions allowed per week and per season in each sport. Statement on Game Official Fees

As many of our members know, there has been much discussion surrounding the fees associated with game officials, specifically ice hockey officials and the upcoming season. All officials are valued and an integral part of every MIAA competition and event. They are vital to the success of interscholastic competition, especially at the high school level.

Each member school has a process for addressing

budgetary needs, many of these processes involve school committee and town voting. Thus, it is unfair to announce or support an increase in fees that impact our members' budgets that does not adhere to a budgetary cycle. The current fees recommended by the Game Officials Committee have been announced and agreed upon to exist in a two-year cycle for that purpose.

Student Eligibility Waiver Deadlines

As a reminder, below are the seasonal deadlines for student eligibility waiver submissions as outlined in MIAA rule 87.1. These are firm deadlines and late waivers will not be accepted.

- Winter December 15, 2024
- Spring April 1, 2025

Middle Level Waiver and Coop Application Deadlines

The winter 2024-25 middle level waiver and cooperative application deadline is December 12, 2024.

Student and Coach Contest Disqualification Forms

Please make sure to use the most up-to-date version of the MIAA Student and Coach Contest Disqualification Forms. These forms were updated in August 2023 and are available in the "Officials" section of the MIAA website. When a student or coach is disqualified from a contest, the required form must be completed by the game official and submitted to the athletic director in charge of the contest before leaving the site. Please note - All fields within the form are required to be completed by the game official, as well as a description of the disqualification **including the violation called.** Forms submitted with incomplete information may be returned to the host school/game official to provide any missing details.

Neck Laceration Protectors for Ice Hockey Required 2024-25

In the spring of 2024, the NFHS Ice Hockey Rules Committee added neck laceration protectors to the required ice hockey equipment. All high school ice hockey players will now be required to wear a neck laceration protector – in its original manufactured state and as intended by the manufacturer – during all MIAA interscholastic contests, scrimmages and practices.
