## **MIAA Board of Directors Update**

On October 9, 2024 the MIAA Board of Directors received and placed on file the following rule clarification: Rule 40.7.2 – Any student who is eligible to attend your school, whether through residency or an application process. This applies to all schools, including public, private, vocational, charter and school choice. Note: This applies to those students covered in rule 40.7.5.

The definition of a Candidate now reads as follows: 40.7.2 A varsity or sub-varsity athlete who participated in a high school program at some interscholastic level the previous year and has eligibility remaining; or 40.7.3 A middle school student "selected" to participate in an out-of-season program.

40.7.4 A sixth grade student in a 7-12 high school or an eighth-grade student in a 9-12 high school.

40.7.5 A sixth grade student in a 7-12 high school or an eighth-grade student in a 9-12 high school.

## **Student and Coach Contest Disqualification Forms**

Please make sure to use the most up-to-date version of the MIAA Student and Coach Contest Disqualification Forms. These forms were updated in August 2023 and are available in the "Officials" section of the MIAA website. When a student or coach is disqualified from a contest, the required form must be completed by the game official and submitted to the athletic director in charge of the contest before leaving the site. Please note - All fields within the form are required to be completed by the game official, as well as a description of the disqualification **including the violation called.** Forms submitted with incomplete information may be returned to the host school/game official to provide any missing details.

## **Student Eligibility Waiver Deadlines**

As a reminder, below are the seasonal deadlines for student eligibility waiver submissions as outlined in MIAA rule 87.1. These are firm deadlines and late waivers will not be accepted.

- o Winter December 15, 2024
- o Spring April 1, 2025

## Middle Level and Coop Application Deadlines

The winter 2024-25 middle level waiver and cooperative application deadline is December 12, 2024.

## The Building Principal as CEO

Any public or private secondary school in Massachusetts that has been approved by the Board of Directors of the Massachusetts Interscholastic Athletic Association (MIAA) receives all the rights, privileges and benefits of the Association. This is achieved through an annual agreement signed by the school principal, headmaster, or director, pledging to adhere to the Association's rules governing athletic activities.

In order to participate in interscholastic athletics under the MIAA, each principal and athletic director must read, understand, and be prepared to enforce all rules, regulations, and policies contained within the MIAA Handbook. Additionally, coaches are expected to have a thorough understanding of these requirements and ensure compliance among their team members.

This commitment to understanding and enforcing the MIAA guidelines serves to ensure that everyone involved in the athletic program, is fully aware of their responsibilities and obligations. Accountability and adherence to the deadlines and protocols set forth by the MIAA membership must be consistently applied in order to provide a means of equitable competition for the entire membership of the Association. It is the ultimate responsibility of the building principal to ensure that all those under their direction conduct the core functions and duties of their responsibilities with fidelity. The building principal has oversight of interscholastic athletics in a secondary school.

The administration of an interscholastic contest or meeting is the responsibility of the school principal or their authorized staff representative, who also acts as the manager of the team or group representing the school. No school can engage in any interscholastic activity without the principal's approval, emphasizing their pivotal role in overseeing the athletic program.

The principal's responsibility extends to the eligibility of each contestant. They are personally accountable for attesting to the eligibility of each participant. The school community takes the matter of allowing an ineligible player to participate in a contest seriously, emphasizing the need for principals to give personal attention to this issue. The building principal may designate and/or delegate certain responsibilities to athletic directors and coaches in their schools, however, ultimately the building principal is the CEO of Interscholastic athletics.

## **Fall Tournament Seeding Guidelines and Schedule**

As we enter Year 4 of the Statewide Tournament format, the MIAA – including tournament directors and seeding committees -- will continue to follow the guidelines developed in Fall 2022 in an effort to streamline the process of producing the final power rankings, and create a smoother process of building and releasing the tournament brackets. Click here for the guidelines and seeding/bracketing schedule for each of the five Fall 2024 power ranked sports, as published in the tournament formats.

#### 2024-25 Schedule Commitment Deadline & Process

Three days before the Schedule Commitment deadline, MIAA staff will produce and publish schedules for each sport based on the available data for review and verification by member schools. Below is the breakdown for the rest of the 2024-25 school year:

- WINTER 2024-2025
  - o First contest date: Thursday, December 12
  - Schedule data published for review: Tuesday, December 17
  - Schedule Commitment deadline: Friday, December 20
- SPRING 2025
  - o First contest date: Thursday, March 27
  - Schedule data published for review: Tuesday, April 1
  - Schedule Commitment deadline: Friday, April 4

## **Tournament Entry - Opt-in vs Opt-out**

Beginning with the Fall 2024 season schools will not be required to submit a tournament entry. Schools will be required to submit communication if choosing to opt out of tournament play. #### Football Handshake Lines - IMPORTANT

Many of our schools and teams are aware of a disappointing and challenging trend starting to appear in football handshake lines. The acronym BTA is being used as they proceed through the handshake line and slap the opponents. Additionally, there have been some reports of "we whipped you" and then a losing team being struck with belts. Please consider getting ahead of this and inform coaches and players about the sportsmanship expectations for all students. The handshake line has been an important part of Educational Athletics, and it serves one purpose only: to celebrate the effort and value of competition. Please ask coaches to address their team about these expectations and by under no means should any player strike or aggressively place hands on another player of the opposing team during the handshake line. Actions such as this must be mentioned in advance and addressed swiftly should they occur. Let's all be aware of how to help our students navigate the social media bluster that can cause severe challenges for players and teams.

Please be aware of fake social media accounts impersonating the MIAA (Massachusetts Interscholastic Athletic Association). The official MIAA account is @miaa033. Any other accounts claiming to be the MIAA may contain scam links or misleading information. Always verify the account before clicking on any links or engaging with content.

## **Field Hockey Protective Equipment Reminder**

The MIAA follows NFHS Rules for Field Hockey. We would like to remind you of the following rule regarding player equipment: NFHS Rule 1, Section 6, Article 5 states: "Goggles may be worn by all field players. A face mask may be worn by field players throughout the game. The face mask shall be smooth, rounded, preferably transparent or single-colored and fit flush with the face. It shall not be attached to any hard, unyielding headgear (even if padded)."

## Additional Important Points:

- Goggles are optional for field players, not mandatory.
- Face masks are permitted for all players during the entire game.
- Face masks must be smooth, follow the contours of the face, and be a single color or transparent.
- Steel or cage-type face masks are not allowed.
- Players wearing face masks must not conduct themselves in a manner that increases risk to other players.

Please ensure that all coaches, players, and officials are aware of these equipment guidelines. If you have any questions or concerns, don't hesitate to contact the MIAA office.

Neck Laceration Protectors for Ice Hockey
Required 2024-25

In the spring of 2024, the NFHS Ice Hockey Rules Committee added neck laceration protectors to the required ice hockey equipment. All high school ice hockey players will now be required to wear a neck laceration protector – in its original manufactured state and as intended by the manufacturer – during all MIAA interscholastic contests, scrimmages and practices.
